

PRE-TAX PLAN CHANGE FORM

INSTRUCTIONS – Use this form to have your benefit contribution deducted from your paycheck on a pre-tax basis. You may also use this form to change your Pre-Tax Plan enrollment.

- Return this form to the Health Care & Benefits Division (HCBD), PO Box 200130, Helena, MT 59620-0130.
- If you are enrolled in a Flexible Spending Account, you must participate in the Pre-Tax Plan. Once a Plan Year begins and the first contribution has been deducted from your paycheck, IRS regulations prohibit employees from joining or dropping out of the Pre-Tax Plan.
- You make your Pre-Tax Plan election as a new employee or you can change your election during the Open Enrollment Period (a two-week period in the last quarter of each year). If your Pre-Tax Plan change is requested during the Open Enrollment Period, it will become effective January 1 of the following Plan Year.
