Off-Site Screenings Begin February 6, 2018!

Dear State Plan Member,

The 2018 State-sponsored Health Screening Schedule is open.

A State-Sponsored health screening is the first step toward earning your 2019 [Live Life Well Incentive!](#)

Schedule your State-sponsored health screening at a Montana Health Center in Anaconda, Billings, Butte, Helena, Missoula, OR at an [off-site event](#).

You must have an appointment to have a State-sponsored health screening:

- Log in at www.carehere.com.
- First time making an appointment with CareHere—register with access code MANA9.
- Select "Blood Draw" next to "What."
- Select "Off-site Health Screenings" **OR** the Health Center of your choice next to "Where."
- Select the **exact date** or date range of the screening you want.

Please schedule your appointment now to ensure you get your preferred date and to allow screening staff sufficient time to prepare for your appointment.

If you cannot attend your scheduled appointment for any reason, please be courteous and cancel your appointment as soon as you know you won't be able to attend. **Please do not schedule multiple appointments.**

If you are attending a screening at a health center, you may be able to add other lab (blood) tests with a prescription/doctor's orders.
