The 2019 State-sponsored Health Screening Schedule is open.

A State-Sponsored health screening is the first step toward earning your [Live Life Well Incentive!](#)

Schedule your State-sponsored health screening at a Montana Health Center in Anaconda, Billings, Butte, Helena, Missoula, **OR** at an [off-site event](#) (such as those listed below).

You must have an appointment to have a State-sponsored health screening:

1. Log in at [carehere.com](#) or call (855) 200-6822. (First time registration code - MANA9.)
2. Click on "Appointments."
3. Under Nurse & Labs, click on "Schedule Appointment."
4. Select "Blood Draw" next to "What."
5. For off-site screenings, select the exact date of the screening you want next to "When" and "Off-Site Health Screenings" next to "Where." For health center screenings, select the health center of your choice. Then click "Get Appointments."

Please schedule your appointment now to ensure you get your preferred date and to allow screening staff sufficient time to prepare for your appointment.

If you cannot attend your scheduled appointment for any reason, please be courteous and cancel your appointment as soon as you know you won't be able to attend. **Please do not schedule multiple appointments.**

If you are attending a screening at a health center, you may be able to add other lab (blood) tests with a prescription/doctor's orders.
