Open Enrollment is Your Annual Opportunity To:

- Update State Plan Coverage
- Add/Change Life Insurance
- Add/Waive Long Term Disability
- Add/Remove Dependent Coverage

Action Required:

- Must Elect or Re-Elect Vision Hardware Plan
- Must Elect or Re-Elect Flexible Spending Account
- Must Self Report Nicotine Use
 - To avoid the \$30 per month Tobacco Surcharge for 2022 you need to annually self-attest your, and if applicable your covered spouse or domestic partner's, nicotine use.
