The Montana Health Center in Anaconda is changing!



- **Effective April 1, 2021 services at the current Anaconda location, 1102 Commercial St., will no longer be available. (See *transition information below.*)**
- The Montana Health Center will re-open in it's new location, 610 E Park Plaza, on July 6, 2021.
- The new location will be dedicated solely to Montana Health Center services and CareHere providers.
- The newly remodeled building will offer increased member service options.

- Make an in-person appointment at the Montana Health Center location in Butte.

 - Butte clinic hours: Monday, Tuesday, Wednesday, Friday 7am - 6pm; Thursday 7am-5pm; Saturday 9am-1pm
- Schedule a TeleVisit with any Montana Health Center provider. Meet remotely on your time and your schedule.

- If you have an appointment scheduled after April 1, CareHere will be reaching out to you to discuss scheduling options.
