State Plan members, it's time to get excited! You'll have a brand new, revamped, and value-added Wellness Portal in 2025! We're still working out the details, so hang tight.

You can still access our <u>current Wellness Portal</u>, <u>Sonic Boom</u>, through December 31, 2024 at 11:59 p.m. PST. After that date, you'll need to wait until the new Portal is up and running to self-report your Live Life Well Incentive Activities. We anticipate the new Portal to be available in February 2025.

- 1. The last day you will be able to access the current Sonic Boom portal is December 31, 2024 at 11:59 p.m. PST.
- 2. If you want to download any of your information from the Sonic Boom portal, you must do it no later than December 31, 2024.



- If you've completed the Health Risk Intervention (HRI) on the <u>Sonic Boom</u> portal and want to download your results, log in to the <u>Sonic Boom</u> portal.
 - Click on the My Health Panel (heart icon in top-right corner),
 - Click View to select your Last Result.

- Click Print Report at the top of the page.

- 3. Any Activities entered into the Sonic Boom Portal for the current Live Life Well Incentive period (November 1, 2024 to December 31, 2024) will be carried forward into the new portal.

- 4. Continue to work towards completing your Live Life Well Incentive Activities. You will be able to self-report those as soon as the new Wellness Portal is up and running.
