### Appointments Available at Off-site Events & All Montana Health Centers

Health Screenings provide a baseline for you and your provider to monitor your health. They can detect "silent" issues such as high blood pressure or infections. Plus, they are free for State Plan members the age of 18 and older!



# Completing a State-Sponsored Health Screening can also help you earn a Live Life Well Incentive!

To earn the Live Life Well Incentive for 2025, you must complete all required Incentive Activities - including a State-sponsored Health Screening - no later than October 31, 2024.

The State Plan covers one State-sponsored Health Screening each Plan Year for members 18 years and older.

- Please do not bring children or other guests unless absolutely necessary.
- If you cannot attend your scheduled appointment for any reason, please cancel your appointment as soon as you know you won't be able to make it.
- Don't attend your appointment if you are not feeling well. Call Premise Health at (855) 200-6822 to reschedule your appointment.

#### Appointments are Required

Make your appointment by typing <u>mypremisehealth.com [mypremisehealth.com]</u> into your internet browser bar, or clicking the link in the Resources section, below.

- If you have already registered with MyPremiseHealth, you may make an appointment at <u>mypremisehealth.com [mypremisehealth.com]</u> or in the Premise Health mobile app.
- Schedule your appointment now to ensure you get your preferred date and to allow screening staff sufficient time to prepare for your appointment.
- Spouses and domestic partners must have their own health screening appointment.

#### Adding Additional Lab Tests

- If you need to add an A1C, TSH, or PSA to your State-sponsored Health Screening, you must bring a prescription or doctor's orders with you to your appointment.
  - No other tests can be added to off-site screenings.
- If you are attending a screening at a Montana Health Center, you may add additional lab (blood) tests with a prescription/doctor's orders (some exclusions may apply).
- Lab orders from an <u>outside provider</u> MUST include a fax number, otherwise the health center staff will be unable to process the lab order.
- Results from outside provider lab orders completed at a Montana Health Center or State-sponsored Health Screenings will NOT be included in your health screening

results or on the Premise website. LabCorp will share the results directly with the ordering provider.

If you need a copy of your outside provider results, you will need to access the LabCorp portal.
