How to Register:

- Visit <u>LiveLifeWellMT.medikeeper.com</u>.
- Click on "Or Click Here to Register."
- Fill in Registration Prompts.
- Use your name as it appears on your BCBSMT medical ID card.
- Accounts cannot be shared. Each State Plan member (employee, retiree, legislator, COBRA enrollee, and their covered spouse/domestic partner) will need to register and create their own account.

If you are a State of Montana employee on the State network, you can access MediKeeper through Single Sign-On (SSO). Visit <u>benefits.mt.gov/incentive</u> and click on the dark blue button under the MediKeeper section. *Dependents and those not on the State network do not have access to SSO and must follow the registration instructions above.*
